SHN 100 CLUB TERMS AND CONDITIONS

- 1.The Shipston Home Nursing 100 Club is a Small Society Lottery run under the provisions of the Gambling Act 2005
- 2. Subscription is £24 a year per number, payable at £2 monthly by standing order
- 3. All proceeds collected will be divided equally between Shipston Home Nursing and the 'Prize Fund.'
- 4. The monthly prize fund awarded will be the full value of the 'Prize Fund' for that month
- 5. The draw will take place on the last Friday of each month, or as soon as possible thereafter
- 6. Players may have multiple subscriptions
- 7. Anybody over the age of 16 years can play
- 8. Each player is allocated a random number in the monthly draw. This number will remain that player's number while their subscription is up-to-date.
- 9. Player's numbers are eligible for inclusion in the draw for any month so long as their subscription for that month has been paid and cleared before that draw takes place.
- 10. The charity administrator will ensure the winner is notified and contacted in a timely manner
- 11. It is the responsibility of each player to ensure their contact details are kept up to date. If a winner cannot be contacted the winnings will be put into SHN funds after six months.
- 12. Any disputes will be resolved by Shipston Home Nursing whose decision is final
